## Overview

---

- The EMSO is the representative organization of international governing bodies the FIA , FIA Karting and FIM and as such, is the only body in the UAE allowed to issue licenses to both, competitors and officials.

-To compete in UAE motorsport, you will need an EMSO Competitor Licence.

-There are various different Licence types and grades within those Licence types, make sure you know which one you need before applying for it.

All EMSO competitor's and officials' licenses include personal accident insurance.

### **The procedures to issue motorsports licence**

1- Apply Online

Competitors can apply for their motorsport's licenses online and ensure you attach all required supporting documents.

2- Obtain NOC

Upon receiving license applications, EMSO forwards competitor details and requests (NOC) for license issuance to the relevant national motorsport's authority in the applicant's home country .

3- Issuing the licence

Upon successful verification of all competitor documents and receipt of the (NOC) from the relevant motorsport's authority in their home country, EMSO will proceed with issuing the license.

## General information about licences :

### 1. License Copies:

EMSO issues soft copies for all national licenses and both soft and hard copies for international licenses.

### 2. NOC Request:

According to regulations (FIA ISC 9.3.2), EMSO sends an NOC request to the competitor's parent ASN for their prior agreement before issuing licenses.

Some countries like Russia , South Africa , Pakistan require the competitors themselves to contact the ASN directly and request NOC .

### 3. Below 18 competitors:

If the competitor below 18 years old additional documents required:

- School letter confirming that the participant is under the UAE education system
- a parental confirmation letter (NOC), is required to issue the license for those below 18 years old.

### 3. Medical Test:

- Required annually for international license applicants
- Required also for those wants to participate in the F4 championship .
- Must be conducted by a UAE-licensed doctor within 3 months of application (FIA-ISC-APPENDIX L –ART.1).
- Required annually for national licence for competitors above 60 years old .

### 4. ECG Report:

- Required every two years with below conditions:  
**45+ years:**
- Stress-related ECG mandatory for all Auto international license.
- Report signed by a Consultant Cardiologist, specifying the test protocol (Bruce Treadmill or Ergometric Bicycle).
- We only require the written report, not the trace.

#### **Under 45 years:**

- Resting ECG required for ANY international license.

To apply, read the details below and apply online:

Online Applications for Entrant, Competitor, Instructor Licences and to upgrade existing valid licences – Emirates Motorsports Organization (emso.ae) .

### 5. License Validity:

Licenses expire on December 31st each year (ART 9.3 ISC).

## 6-Licence issuing time:

Licence approximately will issue 5-7 working days after applying, and it might take more days to issue depends by the case so please make sure to apply for your licence at least 2 weeks before your race.

### **FIA Licenses- (Auto licenses)**

- When processing an FIA License application—whether national or international, new or a renewal for all non-Emirati nationals, the EMSO must first obtain approval from the competitor's home ASN, regardless of whether they have previously held a license in that country (FIA ISC 3.9.4b)

-For all FIA licenses, a valid passport, Emirates ID and visa (excluding UAE nationals) must be supplied each year.

-All FIA competitors' licenses must start with Ax xxx (A for Auto).

### **1-Novice – Restricted:**

Required for Auto tests and basic circuit events. (Time attack and Autocross events).

#### **Required Documents:**

- ❖ Passport copy
- ❖ UAE VISA copy (excluding UAE nationals).
- ❖ Emirates ID copy. (excluding UAE nationals).
- ❖ Medical test if the competitor above 60 years old.
- ❖ School letter confirming that the participant is under the UAE education system if the competitor below 18 years old.
- ❖ Parental Approval letter if the competitor below 18 years old.

**Minimum age:** 16 years old.

### **2-Circuit National:**

Required for Circuit National level events in the UAE.

#### **Required Documents:**

- ❖ Online Application form which includes self- medical declaration form.
- ❖ Passport copy
- ❖ UAE VISA copy (excluding UAE nationals).
- ❖ Emirates ID copy.
- ❖ Medical test if the competitor above 60 years old.
- ❖ School letter confirming that the participant is under the UAE education system if the competitor below 18 years old.
- ❖ Parental Approval letter if the competitor below 18 years old.

#### **Additional Documents:**

For first timers, competitors must present an assessment test certificate showing that competitors have completed the appropriate introductory training from either Dubai Autodrome or Yas Marina Circuit.

**Minimum age:** 16 years old.

### **3-Circuit National Youth:**

-Required for Circuit National level events in the UAE ( Age between 14 and 16 years old).

**-14yr restricted for F4, only testing allowed. Must be 15yr old to race in F4).**

The competitor must have a karting license within the past year and have participated in at least one karting event within the year prior to their application for a Circuit Junior License.

Max 2.5kg/1hp power to weight ratio and max 200hp at crankshaft and must be single make/model race series.

#### **Required Documents:**

- ❖ Online Application form which includes self- medical declaration form.
- ❖ Passport copy
- ❖ UAE VISA copy (excluding UAE nationals).
- ❖ Emirates ID copy.
- ❖ Applicants must hold a Kart National Licence of similar grade
- ❖ School letter confirming that the participant is under the UAE education system if the competitor below 18 years old.
- ❖ Parental Approval letter if the competitor below 18 years old.

#### **Additional Documents:**

For first timers, competitors must present an assessment test certificate showing that competitors have completed the appropriate introductory training from either Dubai Autodrome or Yas Marina Circuit.

**Minimum age:** 14 years old.

#### **4- Circuit International Grade D OR C (ITC-C) (ART 8 APPENDIX L ISC)**

Required for all circuit cars with a weight/power ratio of between 2 and 3 kg/hp.

Single-Seater, Prototype, GT, Touring Car, FIA Autocross Super Buggy, FIA Rallycross Super Car and FIA Truck Championships, or equivalent categories.

Historic Formula One cars (Period G onwards), Formula Two cars (Period H onwards), Indy Cars (Period G onwards), Formula 5000 and Formula A cars (all), Group C cars (all), Canam cars (all), and Sports Prototypes over 2 liters (Period G onwards) regardless of weight/power ratio.

- ❖ Passport copy.
- ❖ UAE VISA copy.
- ❖ Emirates ID copy.

- ❖ FIA E-learning certificate: Drivers applying for an IT C-C Licence for the first time must have undergone FIA e-learning safety training for Circuits. Their preferred module and language version can be selected after sign-in.
- ❖ UAE Road Licence.
- ❖ School letter confirming that the participant is under the UAE education system, along with a parental confirmation letter (NOC), is required to issue the license for those below 18 years old.

**Minimum age:** 16 years old.

**Qualification criteria**

- Applicants must hold before a National Licence of similar grade.
- The driver must be observed to compete satisfactorily to the satisfaction of the Licencing ASN, in at least ten ASN-sanctioned competitions, (minimum of five circuit competitions).
- Competitions in Karting, Single-Seaters, GT, Touring Cars, Autocross, Rallycross, Historic circuit and Trucks, or equivalent (except Drifting).
- Any competitions in other disciplines cannot be considered.

**5- Circuit International grade B (ITB):**

Required for International events worldwide.

Required for all cars with a weight/power ratio of between 1 and 2 kg/hp Single-Seaters, Prototypes, GT and Touring Cars, or equivalent categories

Grade A or B licenses are issued by the driver's ASN, after it has verified that the driver's results, competence and conduct are satisfactory.

- ❖ Emirates ID copy.

- ❖ School letter confirming that the participant is under the UAE education system, along with a parental confirmation letter (NOC), is required to issue the license for those below 18 years old.

**Minimum age:** 16 years old.

**Qualification criteria**

Applicants must hold an International Grade (ITC-C) Licence.

The driver must be observed to compete to the satisfaction of the Licencing ASN, in at least five ASN-sanctioned circuit competitions within the two years prior to application. Should the two-year period include 2020 or 2021, then the three years prior to application should be considered instead.

Competitions for Single-Seaters, Prototypes, GT or Touring Cars, where the minimum Licence required is an IT C-C. Any competitions in other disciplines cannot be considered.

For the avoidance of doubt, the EMSO should request a report from the Parent ASN of the competition should it not be sanctioned by the EMSO.

### **Renewal or expiry:**

In order to maintain the qualification for a Grade B Licence, the driver must participate in at least one international competition of the appropriate category per 12-month period, or otherwise must again be observed, to the satisfaction of the licensing ASN, during practice for an international competition. Should the 12-month period include the year 2020 or 2021, then the 24-months prior to application should be considered.

### **5-Circuit International A:**

Required for International events worldwide

Required for all cars with a weight/power ratio less than or equal to 1 kg/hp. Single-Seaters, Prototypes or equivalent categories

- ❖ Medical test. (You can download medical test form from our website)
- ❖ Passport copy.
- ❖ UAE VISA copy.
- ❖ Emirates ID copy.
- ❖ Online Anti-doping certificate if the applicant applies for the first (please re-upload it if you already have it). **Minimum age:** 17 years old.

### **Qualification criteria**

- The driver must be the holder of a current FIA International Grade B Licence
- The driver must have completed six events in Grade C Championships;

**Maintain:** To maintain the Licence after the first year, the competitor must enter at least one international event over the previous 12 months.

### **7-Rally National:**

Required for National rally level in the UAE.

Required Documents:

- ❖ Online Application form which includes self- medical declaration form.
- ❖ Passport copy
- ❖ UAE VISA copy (excluding UAE nationals).
- ❖ Emirates ID copy.
- ❖ Medical test if the competitor above 60 years old.
- ❖ School letter confirming that the participant is under the UAE education system if the competitor below 18 years old.
- ❖ Parental Approval letter if the competitor below 18 years old.

**Minimum age:** 16 years old.

### **7-Rally National Junior:**

Required for National Rallies, Rally Cross, single seat series, time attack or Autocross format only. (Co driver or driver MUST be above 18).

**max3kg/1hp and max 100hp engine**

Required Documents:

- ❖ Online Application form which includes self- Medical declaration form.
- ❖ Passport copy
- ❖ UAE VISA copy (excluding UAE nationals).
- ❖ Emirates ID copy.
- ❖ School letter confirming that the participant is under the UAE education system if the competitor below 18 years old.
- ❖ Parental Approval letter if the competitor below 18 years old.

**Age:** 13 to 16 years old. (Co driver or driver MUST be above 18).

### **8-Road International D (ITD-R) (Rally international Grade D):**

Required for all International level rallies.

Required for all road cars with a weight/power ratio greater than 5 kg/hp

Required for all road cars with a weight/power ratio greater than 5 kg/hp Sporting Rally cars (Rally3, Rally4, Rally5), Cross Country cars (except T1), or equivalent categories Hill Climb cars, except for cars in Groups CN, D and E2 of Category II as defined in Article 251.1.1 of the FIA Appendix J (W/P ratio not applicable).

#### **9-Road International C (ITC-R) (Rally international grade c):**

Required for all International level rallies.

Required for all road cars with a weight/power ratio greater than 5 kg/hp

Required for all road cars with a weight/power ratio greater than 5 kg/hp Sporting Rally cars (Rally3, Rally4, Rally5), Cross Country cars (except T1), or equivalent categories Hill Climb cars, except for cars in Groups CN, D and E2 of Category II as defined in Article 251.1.1 of the FIA Appendix J (W/P ratio not applicable).

b) with a National Rally Licence of similar grade, in at least ten ASN-sanctioned competitions (minimum of five road competitions). Competitions in sporting Rally, Cross-Country or Hill Climb, or equivalent. Any competitions in other disciplines cannot be considered. For the avoidance of doubt, the Licencing ASN should request a report from the Host ASN of the competition should it not be sanctioned by the Licencing ASN.

**10-Drag National:**

Required for Drag National level events, both in the UAE and abroad.

**Required Documents:**

- ❖ Online Application form which includes self- Medical declaration form.
- ❖ Passport copy
- ❖ UAE VISA copy (excluding UAE nationals).
- ❖ Emirates ID copy.
- ❖ Medical test if the competitor above 60 years old.
- ❖ School letter confirming that the participant is under the UAE education system if the competitor below 18 years old.
- ❖ Parental Approval letter if the competitor below 18 years old.

**Minimum age:** 16 years old

## 11- Drag International:

Required for all International level drag events

- ❖ Online Application form.

- ❖ Passport copy.
- ❖ UAE VISA copy.
- ❖ Emirate ID copy.
- ❖ Online Anti-doping certificate if the applicant applies for the first (please re-upload it if you already have it). **Medical:** A medical section in the application must be completed by every competitor each year in addition, competitors must submit ECG report.

1. For the under 45-year-old (ECG report) every two years.
2. For over 45-year-old and (ECG and stress test) Annual.

**Minimum age:** 16 years old.

## 12-Drift National B: (Free style)

Required for Drift National level events (Free style), both in the UAE and abroad.

- ❖ UAE VISA copy (excluding UAE nationals).
- ❖ Emirates ID copy.
- ❖ Medical test if the competitor above 60 years old.

**Minimum age:** 16 years old.

## 13-Drift National A: (PRO)

Required for Drift National level events (Pro), both in the UAE and abroad.

**14 Drift international /International Grade D Circuit (ITD-C)**

Required for all International Drifting level.

### **Karting Licenses**

The **National** Karting licenses issued to those over 5 years old.

The **International** FIA Karting licenses can only be issued to those over the age of 11.

All 2026 FIA Karting licenses must begin with K YY XXX (K for Kart). The EMSO produces 6 different types of Karting Licence:

### **1-Kart National youth:**

Drivers aged between 5 and 14 (reaching their 14th birthday during the calendar year of participation).

Time Trail or Time attack format 5yr-7yr only

## **3-Kart International Grade G (ITG):**

Required for and limited to Karting OK Junior, Autocross Junior and XC-Junior, or equivalent categories.

### **Age criteria:**

Drivers aged between 11 (reaching their 11th birthday before 1 January of the year of participation) and 14 (reaching their 14th birthday during the calendar year of participation).

- ❖ School letter confirming that they are in full time education.

#### **4-Kart International Grade F (ITF):**

Required for and limited to Karting OK Senior (only non-gearbox categories), Autocross Junior and XC-Junior, or equivalent categories.

Drivers aged between 13 (reaching their 13th birthday before 1 January of the year of participation) and 15 (reaching their 15th birthday during the calendar year of participation).

### **5-Kart International Grade E (ITE):**

Required for and limited to Karting OK-Senior (non-gearbox and gearbox categories), Autocross Junior, XC-Senior, or equivalent categories, regardless of weight/power ratio. Rallycross cars with a weight/power ratio greater than 5 kg/hp

### **Age criteria:**

Drivers aged 14 (reaching their 14th birthday before 1 January of the year of participation).

### **Required Documents:**

- ❖ UAE VISA copy for non-Emiratis
- ❖ Emirates ID copy

**Upgrade Conditions (article 3.3 appendix L)**

2- The driver must be observed to compete to the satisfaction of the Licencing ASN in at least five ASN-sanctioned competitions, as specified in Article 1.9. appendix L ISC FIA. For each race, the form must be signed by the appropriate CoC or ASN Steward.

**Medical:** An annual medical must be completed by all competitors (you can find medical test form and download it from our website).

A Driver’s weight (including the Driver’s equipment) must be a minimum of 35 kg at all times during a competition.

**EMSO MOTO Licenses**

When processing an FIM Licence application for all non-Emirati Nationals, the EMSO must first gain approval from that competitors home Federation, the NOC.

**Note about Moto and FIM single event:**

There is a different procedure regarding FIM international licenses. A rider wishing to compete in an international event (listed on the FIM international calendar), must also apply, through the EMSO, for an FIM One Event or Annual Licence.

All 2026 Moto Licenses must begin with MXX XXX (M for Motorcycles).

#### **Entrants Licenses:**

An entrant Licence is required when a team wishes to officially enter an event, and have their name printed in the official entry list and results. The EMSO only issues Entrants licenses for FIA and FIA Karting, as the FIM operates under a different procedure.

#### **Requirements:**

- ❖ An application form containing the teams name, contact phone number, what type of Licence they require, and a signature.
- ❖ Team Logo

**There are 3 different types of Entrant Licence:**

- **Entrant National** – Valid for a complete year of national level racing.
- **Entrant International** – Valid for a complete year of international level racing.
- **Entrant International (Single Event)** – Valid for only a single international meeting. The specific meeting/event should be named on the Licence to prevent it being reused.

**Instructors licence:**

**There are two types of instructor licences:**

**Grade B:**

Allows you to instruct new competitors who are applying for their first motorsport licence.

- **Requirements:**

1. Copy of passport
2. Emirates ID
3. Participation in a minimum of 5 national races within the last 2 years

**Grade A:**

- Includes all the privileges of Grade B, with the additional authority to assess and certify new instructors.

- **Requirements:**

1. Copy of passport
2. Emirates ID
3. Participation in 10 or more national races within the last 2 years
